On joining members will be required to pay P500.00 as affiliation fees and thereafter pay an annual fee of P500.00 as subscription fees.

Please Note that the affiliation fee will solely be directed to office logistics and is meant to help the coordinating office serve you better. Affiliated members will be granted priority with regard to assistance, support and training. Marang Child Care Network Trust exists to ensure the well-being, protection and care of orphans and vulnerable children through coordination of information sharing, networking, training and policy implementation.

Objectives of Marang

- To provide guidance, coordination and support to members of the Trust offering community-based services to OVC.
- To promote advocacy activities in support of OVC policies for delivery of quality protection and care services.
- To establish standards of care that are in consistent with child care policies as well as international conventions.
- To maintain linkages with agencies in Botswana, regionally and globally who may have information, experience, financial and technical support that would strengthen the work of community based organizations in the area of orphans and vulnerable children.
- To provide technical input to ensure effective integration of OVC psychosocial support in all child programmes and social and economic policies.
- To advise on technical matters relating to implementation, coordination and monitoring of all OVC programmes provided by NGOs. CBOs and FBOs

Membership Guidelines

All CBO/FBO/NGOs shall be referred to as *members* of MCCNT if and when they comply with the following;

1. A member of MCCNT shall comply with Botswana regulations, procedures, policies and other international policies on children issues.
2. All members of MCCNT working with children directly or indirectly shall be *registered* either as a trust (deeds registry-Attorney General), Society (Registrar of Societies), not for profit company or church. Copy will be required.
3. All members working with children under the age of 6 years shall be *licensed* under the Early Childhood Care & Education Policy (2001) and those targeting children above the age of 6 years shall *license* under the Children in Need of Care Regulations (2005). Copy will be required.
4. *Affiliates* shall be members who have paid subscription fees for at least two consecutive years.
5. New CBO/FBO/NGOs shall pay joining fee of P500.00 and thereafter all members will only pay an annual subscription fee of P500.00.
6. All subscription fees shall be paid before February 28th each year.
7. Marang calendar year shall commence from January 1st and end December 31st of each year.
8. All members of MCCNT shall be required to report as per the semi annual achievement reporting template (to be used as an annual reporting template as well). The deadline for the submission of reports shall be the *second week of July* for that year (both achievement reporting template and OVC tracking tool) and the annual report shall be the *second week of January* from the previous year.
9. Profit making organisations, private pre-schools which have not registered under (no. 3 above) and organisations which do not provide child care services will not become Marang affiliates.
10. *Termination of membership:* An organisation intending to terminate its membership with Marang is expected to give at least one month notice of its intentions.
11. Marang shall notify in writing any member who fails to comply with regulations and procedures relating to child care and give at least 2 months notice of termination of membership from Marang.
